<ul> <li>Students have opportunity to request early reinstatement</li> </ul>	
<ul> <li>Discussed revising language for exceptions for graduating seniors:</li> </ul>	
o "Students who would otherwise be academically dismissed but have	
met all graduation requirements, would have the Academic Dismissal	
waived and be eligible for graduation. Students who are granted this	
waiver and graduate, but then return to the institution at the same	
academic level, would return on probation status."
