 A. NIACC and generic APP agreements – Associate Provost Dave Holger

Associate Provost Dave Holger presented two documents, the North Iowa Area Community College and Iowa State University Draft Admissions Partnership Program (NIACC APP Draft) and the generic Admissions Partnership Program, which is modeled from the NIACC APP Draft. NIACC is the third bilateral agreement between ISU and Iowa Community Colleges: the first was with Des Moines Area Community Colleges and the second with Iowa Valley Community Colleges. The benefits to students and to ISU of these programs were discussed. Students wishing to transfer from community colleges benefit from better advising because they are assigned to ISU counselors in their area. ISU benefits because high school students considering attending community colleges are told about the program and may later transfer to ISU.
