Information in support of Form J; Discontinuation of Speech Communication B.A.

Brief Description of the Program

Speech Communication (SP CM), a major in the Department of English, was designed to help students develop their understanding and appreciation of the human communication process and enhance their oral and written communication practice.

Rationale for Termination

While enrollment in several of the skill-based SP CM courses continues to be robust, interest in the SP CM major has been declining for at least the past five years. There are currently fewer than 10 majors in the SP CM cohort. Competing majors like Communication Studies (COMST) are viewed as offering a broader, more workplace-applicable course of study; because SP CM focuses heavily on rhetoric, it is considered less appealing among prospective students. We are therefore requesting that this program be permanently discontinued.

In addition to the major, SP CM has offered general education courses as well as a SP CM minor, which would be retained under the current proposal. The specific courses in the SP CM major to be eliminated are:

SP CM 305 Semantics

SP CM 313 Communication in Classrooms and Workshops

SP CM 322 Argumentation, Debate, and Critical Thinking

SP CM 327 Persuasion

SP CM 404 Seminar

SP CM 412 Rhetorical Criticism

SP CM 416 History of American Public Address

SP CM 495 Directing Speech Activities

SP CM 497 Senior Seminar

SP CM 499 Communication Internship

Plan for Accommodating Currently Admitted SP CM Students

The department has devised a plan that will allow current SP CM majors to complete their degrees within three years. Using the SP CM courses that remain and substitutions when needed, advisors will work with these students to define pathways that achieve their learning and career goals while also meeting graduation requirements.

Effects on Costs and Resource Reallocation

The department is expected to save \$75,780 by eliminating the nine courses above. No reductions in staffing are anticipated as a result of this change. Faculty and staff who currently teach courses in the SP CM major are well-versed in their subject areas and teach a wide variety of other courses, so the additional teaching capacity created by the sunsetting of the major can be redirected to fill gaps left by other cuts.

Availability of Program Elsewhere in Iowa

ISU's Speech Communication program was the only one of its kind in the state. We will continue to offer the more popular COMST major. In addition, UI offers its own B.A. in Communication Studies, and UNI offers a B.A. in Communication.

Affect on Workforce Needs in Iowa

Workforce needs are not expected to be affected because of the existing undergraduate Communications and Communication Studies programs at all three Regent Universities. In addition, the retained SP CM minor will still address the oral skills sought by employers.

Anticipated Impact on Other Programs at ISU

Eliminating the SP CM major is not expected to have significant effects on the strength of other ISU programs. SP CM has been successful as an addition to other majors (including majors outside LAS), so it may in fact be more effective as a minor. Courses cross-listed with SP CM, such as WGS/SP CM 323, will not be impacted because the vast majority of those classes will remain intact for the minor as well as for general education options for students across colleges.

Anticipated Impact on Student Subgroups

Elimination of the SP CM major is not expected to significantly affect the education of subgroups of students, such as minorities or women, because most of the courses targeted for elimination do not focus on gender, sexuality, feminism, or diversity. Those SP CM courses that do touch on these issues, such as WGS/SP CM 323, will be preserved in the minor and in general education electives for students across colleges. The department may actually be in a better position to attract women and minorities to our retained courses going forward because we will have more time to dedicate to that endeavor once the major has been sunset.
