<p><b>Majors and Minors</b></p> <ul style="list-style-type: none"> <li>Policy proposed by work group (proposed changes in green):                             <ul style="list-style-type: none"> <li>Drop stand alone credits for multiple majors, certificates and minors</li> <li>Secondary majors: Define and require at least 24 credits (at least 12 taken at ISU at &gt;300-level)</li> <li>Minors: Increase # credits taken at ISU at &gt;300-level to 9 (currently 6)                                     <ul style="list-style-type: none"> <li>Alternate: 3 credits at &gt;200, 6 credits at &gt;300</li> </ul> </li> </ul> </li> <li>Recommendations                             <ul style="list-style-type: none"> <li>Best practices will be developed to guides programs reviewing/revising their minor, certificates, secondary majors</li> <li>Colleges and departments can be more restrictive in requirements for multiple majors, certificates and minors (i.e. require stand alone credits)</li> </ul> </li> <li>More questions                             <ul style="list-style-type: none"> <li>Multiple Bachelor's Degrees – remove requirement of at least 30 additional credits                                     <ul style="list-style-type: none"> <li>Updates – peer institutions – multiple degrees &amp; multiple majors</li> </ul> </li> <li>Can students complete requirements for minor after completion of degree from ISU or another institution?</li> </ul> </li> </ul>	Jennifer Suchan Terri Boylston
